ACAM AWARDED 23 GRANTS FOR ORGANIZATIONAL AND PROFESSIONAL DEVELOPMENT PROMOTING SOUND PRACTICES IN NONPROFIT OPERATIONS AND PROGRAMMING, AND SUPPORTING ORGANIZATIONAL PLAN IMPLEMENTATION THROUGH TRAINING AND CONSULTING STIPENDS AND DIRECT GRANTS.
